<u>ANNOUNCEMENTS</u>—Mr. Michel updated the Board on famous figures. He explained that we will be republishing the budget to have the authority to spend at least our allotted amount for at risk. Grade cards will be mailed. Mr. Dronberger shared the KSHSAA summer guidelines with the Board. New NHS members were announced. A hall gate for the high school was purchased with funds from a grant received from Midwest Energy.

<u>**GRADUATION**</u>—Mr. Dronberger held two zoom meetings with the seniors to get their input and ideas for graduation this year. They have expressed that they would like an in-person ceremony on July 26 with bacceloreate at 8:30 am and the ceremony at 11:00 am either in the auditorium or the football field. Mr. Dronberger has been in contact with Nex-Tech to see about live-streaming the graduation in case of guest limitations.

**<u>RANDOM DRUG TESTING UPDATE</u>**—Mr. Dronberger had two zoom meetings with parents to explain the random drug testing process, and will possibly have one in-person meeting in August and has sent survey results to the Board. He is hoping to approve the policy in July. <u>**TENNIS CO-OP WITH RUSSELL**</u>—Mr. Dronberger and Mrs. Gabel spoke in regard to the possibility of a tennis co-op with Russell. No action was taken.

<u>VES ELEVATOR UPDATE</u>—Mr. Michel updated the Board on where things are with starting on the elevator project. He explained that they are waiting on approval from the fire marshal to move forward. Contracts have been signed and a pre-construction meeting will be held next week.

**<u>STATE BUDGET</u>** —Mr. Michel stated that the state has received \$1.2 billion to address costs of the Coronavirus pandemic, but it is not clear if those funds can be used to replace lost

revenues for state and local operating budgets. Dale Dennis thinks Governor Kelly is going to stay away from cutting education. The legislature will meet on May 21.

**<u>CARES ACT</u>**—Mr. Michel shared with the Board that we received \$15,297 from the CARES Act which is based on the district's Title I program. (Exhibit F)
